### Eligibility

Requesting organizations should meet one or more of the following criteria:

- Public organizations with 501(c)3 tax-exempt status;
- Local government units if the charitable contribution is used exclusively for public purposes;
- Serves a community need within American Broadband's market area.

American Broadband does not provide contributions for longer than one year. Some organizations submit multi-year proposals; however, only the first year is considered for approval. Subsequent review and evaluation is required for future support.

We do not make contributions to individuals (generally), for-profit businesses, third-party fundraising organizations, government agencies, political organizations, campaign causes or candidates, or for lobbying or religious purposes.
